the GAL7 Foundation, suddenly lost her husband of 39 years, Robert ("Bob") Finder, on June 13, 2017. Mr. Finder was a strong advocate of the idea that we are "our brother's keeper" and as a society we must help all those who are less fortunate to live a better life with hope for the future.



During his years as Chief Negotiator for the State of Connecticut, he implemented the Workers Compensation Unit and negotiated an overhaul of the state employee pension system, which allowed 5,300 state workers to avoid the pension crisis that plagued many other states. His advocacy included post-retirement teaching in the Teenage Parent Program at Hartford Public Schools, helping teens earn their high school diplomas. Steps to a Quickly Processed Funding Request


- 1. Discuss your need with your CAM
- Visit GAL7Foundation.org website to identify other possible funding and advise what other funding has been explored
- 3. Get Funding Request Form from GAL7Foundation.org
- 4. Fill out the form in <u>specific</u> detail of child's needs (size, color, quantity, item#, etc.)
- 5. Advise how (pickup/delivery), where and to whom item is to be delivered.
- 6. Submit online for fast processing. Questions? email directly to Funding Chair anwoznia44@gmail.com
- 7. Upon approval by the Funding Committee, you will receive funding and be responsible for providing receipts (unless item is available & ordered by the Foundation through Wal-Mart)

Pandora

On July 1st, a law went into effect authorizing therapy dogs in Courts throughout Florida. Therefore. GAL7 Foundation. Inc. is delighted to introduce our long awaited pilot program, Friends of Pandora, providing a dog therapy team to



Flagler County Dependency Courts and the Flagler County Guardian ad Litem Program.

Pandora is a 4-year old golden retriever from New Horizons Service Dogs, Inc. Donna Brown, a certified Flagler GAL and the GAL7 Foundation's Treasurer, is her handler. Pandora has over two years extensive advanced training and has trained with Donna for an additional two years.

The bond between dogs and children is magical, providing emotional relief for the children during anxious and stressful times. Pandora's "job" may include accompanying those children afraid to appear in court, entertaining the children waiting in the hallways for their appearance before the Judge, and accompanying the supervision of children after their appearance before the Judge. Future plans involve expanding the program to the other counties in Circuit 7.
